The Award process

Submissions will be open until 15 of April 2018. Between then and Mid- May

the European Advanced SDG-Award-Jury will review entries against a standard-marking scheme and decide upon the Award-winners in the different categories, whereas there may be several award-winners per category.

Any company including multinationals, SMEs, start-ups, etc. or institutions as well as NGOs may send their formless applications explaining their explicit success in the implementation of the SDGs.

The **standard marking scheme** consists of the following criteria:

- **Frontrunner** in the sector in respect to the realization of the SDG-goals spirit in the entire business model, showing an measurable impact in the respective sector
- Implementation of SDGs beyond current mainstream sector activity
- Any other initiative that may serve as "best practice" in the specific field with a view to effectively contribute to the detoxification of the system earth

(elimination/reduction of chemicals, fertilizers, etc.)

- European company, institution or NGO (headquarters in a European country)
