PLAGIARISM FORM

What is Plagiarism?

Plagiarism is taking another person's words, images, tabular data etc. and presenting them as your own.

An author's work must be expressed in his/her own words and incorporate their own ideas, research, and judgements.

For direct quotations from published or unpublished work of others, full credit should be given to the source.

It is not expected that what an author writes will be wholly original to him/her; the author will of course be using information learnt from reading journal articles/books/information on internet. However, it is expected that an author will present this information largely in his/her own words, and offer his/her own views. When an author quotes or paraphrases closely from a source, the author must obtain permission from the publisher/author of the copyrighted work.

Published works of the author (own works) also require clearance from the publisher of the journal/ book in which it has been published.

If figures and / or tables are reproduced in your article from sources like books, journal etc., you must obtain written permission from the copyright owner.

Any work that is plagiarized must be omitted from the chapter and if published then the authors, not the publishers, will be liable for any costs or damages.
